Dear Mr. President:

On behalf of the National Restaurant Association and our state restaurant association partners, thank you for recognizing the workforce challenges facing key sectors like agriculture, leisure, and hospitality. Within this broader landscape, the restaurant industry stands as a powerful economic engine – generating over \$1.4 trillion in annual economic activity and supporting more than 15 million jobs nationwide, more than any other sector in hospitality. Restaurants do not only feed communities – they anchor local economies, serve as the nation's leading first-job provider, and play a vital role in the American food supply chain by ensuring affordable, accessible, and domestically produced meals for millions of consumers every day.

As you recognize, the workforce challenges facing farms and hotels also extend to the restaurant industry. Restaurant operators, farms, and hotels rely on longtime, law-abiding workers in order to better serve our national food and hospitality supply chain.

Today, there are more than 1 million unfilled jobs in the foodservice and hotel industries. Nearly one in three restaurant operators report they lack sufficient employees to meet customer demand, and 77% struggle to hire and retain staff. These shortages limit operating hours, reduce services, and strain restaurant operators and the communities they serve across the country.

We respectfully urge you to consider the following actions:

- Exercise your authority strategically by prioritizing the removal of individuals who pose a threat to national security and public safety.
- Partner with our industry to implement targeted workforce solutions, ensuring sectors like agriculture, hospitality, and foodservice can hire and retain essential immigrant workers.
- Consider deferred action with work authorization on a select basis for long-serving employees who pass background checks, pay taxes, and meet rigorous vetting standards. This targeted relief has precedent and would provide continuity and workforce stability.
- Advance long-term immigration reform with Congress to support individuals who contribute to our economy and aspire to build a better future through hard work.
