OF THE RESTAURANT & FOODSERVICE INDUSTRY



SUMMER 2025 In 2025, Maine's eating and drinking places are projected to contribute **\$6.35B in direct economic output** to the state's economy, support **58,048 jobs**, and deliver **\$2.18B in labor income**, including wages, salaries, and proprietors' income, and benefits.

These contributions spur additional spending in the U.S. economy. When including indirect and induced impacts from employees, suppliers, and others in the surrounding area, the industry's economic impact rises to \$10.68B in output, supporting 78,454 jobs, and \$3.58B in labor income.

The industry will also be a major source of public revenue. Direct contributions will **\$1.16B in taxes** to all levels of government, including \$16.27M in county taxes, \$339.42M in state taxes and \$514.30M in federal taxes. With induced and indirect effects included, contributions will reach **\$1.77B in taxes**, with \$22.52M in county taxes, \$494.62M in state taxes and \$851.42M in federal taxes.


