SUMMER 2025 In 2025, Tennessee's eating and drinking places are projected to contribute \$37.06B in direct economic output to the state's economy, support 336,980 jobs, and deliver \$12.25B in total labor income, including wages, salaries, and proprietors' income, and benefits.

These contributions spur additional spending in the U.S. economy. When including indirect and induced impacts from employees, suppliers, and others in the surrounding area, the industry's total economic impact rises to \$63.47B in output, supporting 453,351 jobs, and \$21.09B in total labor income.

The industry will also be a major source of public revenue. Direct contributions will total **\$5.58B in taxes** to all levels of government, including \$399.5M in county taxes, \$1.86B in state taxes and \$2.79B in federal taxes. With induced and indirect effects included, total contributions will reach **\$8.89B in taxes**, with \$570.12M in county taxes, \$2.71B in state taxes and \$4.84B in federal taxes.









